1.0 **Title**:

Provision of Inspection Window in filter cubicle.

2.0 **Object**:

Due to inaccessibility for visual inspection of contactor panel of filter cubicle in 'ON' position, it is impossible to check the tightness of power cables and shorting bus bars for its looseness as well as visual inspection for any heat mark etc.from outside.

To over come the said problem ,ELS/GMO has carried out a modification in filter cubicle panel by providing a window of 360mm X 280mm on the left side of filter cubicle panel, which is helpful in providing accessibility for the visual inspection of contactor panel, power cables and bus bar connections during every maintenance schedule/periodical inspection of locomotive in shed.

3.0 Existing Arrangement with cross-references of respective design document:

Earlier, no inspection window was provided. But later, CLW started providing smaller size inspection window (310mm x 210 mm).

4.0 Modified Arrangement to replace existing arrangement as given above in 3.0:

Inspection window of size 360mm x 280 mm is to be provided as per drawing no. SKEL-4749, Alt.'0'.


