Sub.: Selection for the post of Chief Vigilance Inspector/Mechanical in Level-7 (Pay Matrix) in Vigilance Organisation of RDSO/Lucknow.

In order to fill up the following ex-cadre post in the Vigilance Department, RDSO/Lucknow, applications are invited from the eligible candidates (proforma enclosed):

1.	Chief Vigilance Inspector/Mechanical Level-7 in Pay Matrix of 7 th CPC (Grade Pay 4600/- in PB-2, 9300-34800 of 6 th CPC)	01

2. Eligibility and Terms and Conditions:

- i) Candidates upto 50 years of age (on the date of notification) and holding a post in Mechanical Department over the Indian Railways in Level-7 of Pay Matrix / 7th CPC or one scale below i.e., in Level-6 of Pay Matrix / 7th CPC on regular basis, may apply.
- ii) The candidate should have completed at least **five** years continuous service in Railways on the date of notification.
- iii) Candidate who have already completed their tenure in Vigilance Organisation of Zonal Railways/Production Units/Railway Board as Investigating Inspector (Vig.)/Vigilance inspector would **not** be considered.
- iv) The staff/inspectors working in Inspection Cell of Quality Assurance Directorates of RDSO, who have joined on deputation from the Railways and are currently serving deputation would **not** be considered.
- v) The staff/inspectors who have completed their specified tenure (of deputation from Railways) in Quality Assurance directorate and are subsequently working in other directorates of RDSO would **not** be considered.
- vi) The staff/supervisors serving deputation in Railway PSUs may apply, however, their application should be forwarded by the respective Cadre Controlling Authority of their parent Railway.
- vii) The candidate should have flair for vigilance work, i.e., in vigilance investigation and other associated works.

- viii) Working knowledge of Computers is **mandatory**.
- ix) Application of only those who can be spared on selection may be forwarded. It may be noted that it will be compulsory to relieve the candidate after selection.
- x) Vigilance is an ex-cadre unit. The candidate selected for their posting in the Vigilance Deptt. will continue to maintain their lien and seniority in their parent department/cadre.
- xi) Candidate who would be applying in response to this notification should note that they are required to join immediately and refusal to join the relevant post will not be agreed to and the same would be viewed seriously.
- xii) Though the normal tenure of Vigilance Inspector is four years, continuation as Vigilance Inspector depends on the individual's performance and integrity. The Vigilance Inspector is liable to be repatriated to their parent department at any time, short of completion of the specified tenure, without assigning any reason.
- xiii) Applications should be submitted in the proforma enclosed, complete in all respects and duly signed by the Applicant. Submission of false or misleading information by the candidate would lead to D&AR action.
- xiv) Applications should be submitted through proper channel and after obtaining necessary approvals.
- xv) The candidate should have sound integrity, should not be figuring in any current Vigilance/SPE case and should not have been imposed any penalty in any past Vigilance/SPE case. Also, the candidate should not have undergone any penalty under non-Vigilance (administrative cases) during the last **three** years / be undergoing (currently) any penalty under non-Vigilance (administrative cases).

3. Method of Selection:

- i) All applications received upto the last date will be Screened by a Screening Committee.
- ii) Those candidates who are found suitable by the Screening Committee would be subjected to a Written test and a Vigilance Aptitude and Computer knowledge test which would be conducted in the form of viva-voce. The distribution of marks for selection is stated below:



Candidates who obtain at least 60% marks in the written examination would be called for appearing in the Vigilance Aptitude & Computer knowledge test and those who are securing 60% of marks including Written test, Vigilance aptitude, Service record (APARs) and Academic qualification in aggregate would be eligible for empanelment.

4. Syllabus for the Written test:

- i. General knowledge of rules including knowledge of Discipline and Appeal Rules - 1968, inquiries and ability to marshal facts to write reports.
 - ii. Questions related to the concerned discipline.
 - iii. Writing of self-contained investigation report on a case including framing of draft chargesheet.
 - iv. General Knowledge and IQ.
 - v. Question related to Rajbhasha.

5. Wide publicity of the above vacancy notice may kindly be given and it should also be displayed prominently on notice boards for information of the staff.

It is requested that the application of the eligible candidates duly filled up in the enclosed proforma may be sent to the office of Joint Director Vigilance, RDSO, Room No. 12A, Administrative Building, Manak Nagar, Lucknow - 226011 through proper channel along with D&AR/SPE/Vigilance clearance, complete vigilance history and attested copies of APARs of last 03 years (i.e., 2018-2019, 2019-2020 and 2020-2021).
7. **The last date of receipt of application in this office would be 15.05.2022** Applications received after the prescribed date or without proper forwarding through proper channel/Competent Authority would not be entertained under any circumstances.
