3. The validity of quotation will remain open for 90 days from the date of opening of quotations.
4. Income Tax as applicable shall be deducted at source from contractor's bill. However payments will be made under FCM in respect of GST, which is to be submitted by the contractor at his end.
5. The guarantee period of the work shall be **TWELVE MONTHS** from the certified date of completion of the work.
6. Payments will be made after completion of work duly certified by work supervisor in-charge.
