



Chief Medical Officer, RDSO Hospital, Lucknow on behalf of President of India is inviting "Expression of Interest (E.O.I.) from various reputed Diagnostic Centre/ Hospitals of Lucknow for Pathology & Radiological Investigations on current CGHS rates of Lucknow as per terms and conditions detailed in Railway Board:

- Letter no. 2011/H/6-4/Policy Dated: 03.02.2015
- Letter no. 2021/H-1/11/10/MoU Dated: 03.06.2022

Qualifying criteria for Pathology/ Radiology Investigation

- a. The lab must be either CGHS empanelled or NABL accredited.
- b. Centre should have full time qualified, Pathologist.
- c. Centre should have full time qualified, Radiologist.
- d. Centre should have facility of Digital X – ray, Colour Doppler and Ultrasonography.
- e. Centre should have 128 slice or more multi slice spiral CT machine.
- f. Centre should have 1.5 Tesla or higher strength MRI machine.
- g. Centre should mention regarding availability of PET scan machine.
- h. UP State Government approved COVID – 19 RT-PCR testing facility.
- i. Report of the scan should be ready by 6 pm on the day of investigation.

Other Conditions:

- i. The rates charged will be as per CGHS prescribed rates. In case CGHS rate is not available then AIIMS rate or any other government hospital rate shall be applicable. In case no government rate is available then reasonable rate as per agreed discount on hospital rates shall be payable.
- ii. No payment will be charged from any referred case.
- iii. Diagnostic centre that are recommended for empanelment shall also have to furnish a Performance Bank Guarantee valid for a period of 30 months i.e 06 months beyond empanelment period. Deposit – Rupees Two Lakhs (Rs.2,00,000.00) in favour of PED, Finance & Accounts, RDSO, Lucknow in form FDR / Bank Guarantee issued by Nationalized Bank.
- iv. Empanelment diagnostic centre/lab will be required to provide bank detail for necessary transfer of bill amount electronically to the account.
- v. Empanelled lab should notify one contact person of the lab who can be contacted by Railway beneficiaries /Railway administration in case of any requirement.
- vi. The empanelled lab should submit rate list of their centre along with discount for those investigation where CGHS/AIIMS/Govt. approved rates are not available.
- vii. Chief Medical Officer, RDSO Hospital, RDSO, Lucknow reserves the right to accept / reject any application/ to reject all the application at any time, without assigning any reason.
- viii. Railway beneficiaries will be referred to empanelled centre with proper referral letter. It will be duty of empanelled lab to verify the credential of the referred railway beneficiary before doing investigations.
- ix. In case of any doubtful test result, lab will repeat the test without any extra charges.
- x. If any empanelled Lab is found involved in any wrong doing or over charging etc., then the concerned Lab would be suspended/removed from Railway panel and can be black listed for future empanelment with Indian Railways.

 - b. Number and Qualification of Doctor's and Paramedical Staff working at their centre along with their Certificates.
 - c. CGHS empanelment certificate.
 - d. NABH/ NABL Certificate with scope of accreditation.
 - e. Any other relevant permission certificate (registration with the centre/ state authority) for conducting specific Pathological/ Radiological test from Centre/ State Health Authority.
 - f. List of investigation facilities available with the LAB:- Proposed Rates for Various Pathological Test/ Radiological Investigation which are done in your institution, also mentioning percentage of discount offered for investigations not covered under CGHS /AIIMS Rate.
 - g. Copy of compliance with statutory requirements including that of waste management.
 - h. Approval from UP State Government for COVID – 19 RT-PCR testing.
 - i. Aadhar card and PAN card of Authorised signatory.
 - j. PAN Card of organisation
- xii. Empanelled lab will nominate one technician for collection of all samples for Pathology Test at RDSO Hospital, Lucknow from 9:00 AM till 11:30 AM from the collection point at the hospital. No conveyance charge or any additional charge will be admissible for the person assigned by the Lab to collect samples for RDSO Hospital.
 - xiii. In case of emergency, samples can be sent directly to the lab by the hospital.
 - xiv. Urgent blood and radiological investigation with reporting will be done in Emergency whenever required.
 - xv. A soft copy of the investigation report of every day should also be forwarded to the email address of pathology department/ RDSO Hospital.
 - xvi. In light of on-going digitalization of health care system in Railway hospitals, any change regarding providing reports will be binding on the empanelled labs.

Tenure of Contract:

The period of initial contract will be for 02 years from the date of issue of letter of acceptance and rates prevailing at the time of contract will be valid throughout the period of the contract.

Termination of Contract;

The contract can be terminated at any time, on one month notice on either side. The CMO/RDSO reserves the right to terminate the contract without assigning any reason. However, the same will not apply in case of erroneous reporting and contract will be terminated with immediate effect.

Application:

- i. Applicants should submit their willingness in an application, the format of which is given in Annexure – 1 and 2.
- ii. Each page of the EOI document, application and copies of all documents/ certificates/ credentials of qualification should be signed/ self-attested by authorised signatory on behalf of the organisation/ lab.
- iii. Duly filled application, complete in all respect, with all required signed/ self-attested by authorised signatory. Relevant documents/ certificates and credentials, contained in a sealed cover should be



- iv. Railway will not be responsible for any delay in submission of the application, either personally or by post.
- v. Any conditional offer will summarily be rejected.
- vi. All disputes and differences come under the General conditions of contracts 2018 and with update amendment of general conditions of contract 2018, if any. In the event of any disputes arising between the parties hereto, such disputes and differences shall be removed by mutual consultation. If such resolution is not possible then the unresolved disputes and differences shall be referred for arbitration to an Arbitrator to be nominated by the Director General/ RDSO, Lucknow. The Arbitration Act (Latest) shall be applicable for the arbitration. The award of Arbitrator shall be binding upon all parties involved in the dispute.
- vii. All the disputes if any arises will come under the jurisdiction of the District and Subordinate Courts of Lucknow only.
- viii. **EMPANELLED HEALTH CARE ORGANISATION'S INTEGRITY AND OBLIGATION DURING AGREEMENT PERIOD:** The empanelled Lab/ Diagnostics centre is responsible for and obliged to conduct all contractors activities in accordance with the agreement using state-of-the-art methods and economic principles and exercising all means available to achieve the performance abide by the directive used by the Railway. The Lab/ Diagnostics centre is also responsible for managing the activities of its personnel and will hold itself responsible for their misdemeanour, negligence, misconduct or deficiency in services, if any.
