**Sub.:** Discussion on bearing seizure cases of BHEL make Traction motors type 6FRA6068 in new locos.

- 1. A meeting was conducted through Video Conferencing on 03.03.2021 on Traction Motor (6FRA6068) bearing seizure cases of BHEL make TM. Recently in new locos fitted with BHEL make TMs, bearing seizure cases have increased sharply in last two months. Some sheds (BRC, GMO, LDH etc.) have reported that in most of the cases, end frame bore diameters are being found out of limit (generally on higher side). Some of the locos have failed either during commissioning or /just after few days of commissioning due to bearing seizure. ELS/BRC & ELS/LDH have reported that they have dismantled other healthy TMs of M/s BHEL & observed the same problem of dimensions of end frame out of limit. Railway Board has shown serious concern on the issue during the meeting:

A meeting was conducted through Video Conferencing on 03.03.2021 on Traction Motor (6FRA6068) bearing seizure cases of BHEL make TM. Recently in new locos fitted with BHEL make TMs, bearing seizure cases have increased sharply in last two months. Some sheds (BRC, GMO, LDH etc.) have reported that in most of the cases, end frame bore diameters are being found out of limit (generally on higher side). Some of the locos have failed either during commissioning or /just after few days of commissioning due to bearing seizure. ELS/BRC & ELS/LDH have reported that they have dismantled other healthy TMs of M/s BHEL & observed the same problem of dimensions of end frame out of limit. Railway Board has shown serious concern on the issue during the meeting. Outcome of the meeting is as follows:-

- 1. M/s BHEL will submit the action taken & action plan for future for addressing the issue of bearing seizure cases due to use of improper size of associated components in next 2-3 days.
- 2. CLW will carry out the audit of M/s BHEL's sub vendors who are supplying the associated components in coordination with M/s BHEL. M/s BHEL will extend all possible support to CLW to carry out the audit in a time bound manner. BLW, DMW & RDSO Inspection wing /BPL have willingly agreed to provide support to complete the task within a months' time. Accordingly, CLW is advised to issue the schedule of audit in next two days.
- 3. ED/Inspection/Bhopal/RDSO informed that BHEL's QAP for traction motor ype 6FRA6068 is valid till 31.03.2021. CLW is advised to examine the QAP to make necessary provisions so that recent problem can be addressed during inspection.

4. M/s BHEL is advised to submit their work instructions for assembly of 6FRA6068 TM including bearing & associated components fitment to ED/Inspection cell, Bhopal in next 2 days.

5. Railway Board has advised M/s BHEL to replace the failed TM as per warranty clause

immediately.
