INVITING APPLICATIONS FOR ENGAGEMENT OF HONORARY VISITING SPECIALIST (HVS)
DOCTORS FOR RDSO HOSPITAL LUCKNOW.

Applications (EOI) are invited from eminent specialist doctors, who are willing to come and work in RDSO Hospital Lucknow, as **Honorary Visiting Specialist (HVS)** on contract basis. The specialist will provide professional services to the beneficiaries of railway on payment of honorarium as per terms and conditions detailed in Railway Board letter no. 2014/H-1/12/8/HVS policy Dt.19.06.2018 and letter no. 2018/Trans.Cell/Health/Medical issue dt.24.08.2018.

- 1) **Qualifications & Experience:-** Postgraduate Qualification degree from a recognized University& obtaining 03 years' experience in the professional work related to concerned specialty after obtaining PG degree. In the absence of suitable candidates with PG Degree, PG Diploma holders with 05 years' experience in the professional work related to concerned specialty after obtaining Diploma.
- 2) **Age profile:-** Maximum age 64 years as on 01.08.2024.
- 3) **Tenure of working:-** The offer is initially for one year only. After expiry of tenure, extension can be given on the basis of Performance Report.

- 5) **Daily rate of reduction of remuneration:-**HVS will be allowed to avail 12 days leave during every year. For any absence beyond 12 days deduction will be made at the following rates.

- 6) **Railway Passes:-**
 - (i) One set of complimentary Railway Pass valid all over IR & Konkan Railways in AC Two tier including Rajdhani Express & in AC Chair Car of Shatabdi Express for self, spouse & dependent children's (as per pass rules for Railway employees) will be made available as per the entitlement of Selection grade officer in each calendar year.
 - (ii) Complimentary Railway Pass can be availed after three month of continuous service after engagement for the calendar year.
- 7) Last date of receiving of application in this office **16.08.2024** by **15.00** hrs.
- 8) **Termination of contract:-** The contract can be terminated at any time, with one month notice from either side. The administration reserves the right not to assign any reason.
- 9) **Other conditions:-**
 - i) No conveyance or conveyance charges shall be admissible to come at the place of duty and going back and no extra charges shall be admissible for attending emergency cases.
 - ii) In case, if the HVS is unable to attend hospital, he/she will have to intimate the In-charge of the Hospital so that work can be managed accordingly.

- iii) HVS will not be allowed to see and treat their Private patients in the Railway Hospital.
- iv) HVS is not authorized to issue any certificate either to Railway employee or their family members and dependent relatives in official and private capacity.
- v) No upward revision of the rate of Honorarium during the period of contract will be considered unless there is any clear RB Policy.
- vi) Further, Railway shall not be responsible for any delay in the payment of honorarium in case there is paucity or non-availability of funds and will not be liable to pay the interest thereof.
- vii) The concerned HVS shall in all times, indemnify and keep indemnified Indian Railway against all such actions, suits claims and demands brought or made against him, in respect of anything done or purported to be done by them in execution of or in connection with services under this agreement and against any loss or damage to Indian Railway in consequence to any action or suit being brought against the Indian Railway.
- viii) The HVS shall at all-time abide by the job safety measures and other statutory requirements prevalent in India and shall keep free and indemnify the Indian Railway from demand or responsibilities arising from accidents or loss of life resulting from the negligence or misconduct of them.
- ix) No transfer to other Railway Hospital will be allowed.
- x) The procedure of engagement will be as per guidelines of Railway Board.
- xi) Applicants may be asked to show the original certificates.
- xii) Selection will be made on basis of Document, screening of the applications, A committee of 03 doctors will forward recommendation, for approval of PCMO/RDSO and, DG/RDSO Lucknow for acceptance.
- xiii) Applicants, whose names are recommended for HVS and accepted by DG/RDSO Lucknow will have to enter into an MOU with Railway.

- II. Each page of EOI Document, application and copies of all documents /certificates & credential's, qualification, experience and trainings etc. should be signed/self-attested Photographs should be signed on the back.

- V. Any conditional offer will summarily be rejected. Railway reserves the right to accept or reject any offer without any notice/assigning a reason to the concerned applicant.
