





Sl. No.	Query Raised by the firm	RDSO's Clarification/Comments
1	We are the distributors for Foreign OEM, Fire Testing Technology Ltd U.K. we want to submit offers in GBP for main equipment and accessories in GBP with payment terms direct to the OEM and consumables like gases etc for test and demonstration in INR. How to submit offers?	Please read Para 1105 of GT-EITT-March 2016 in response to your query which is quite clear. However authorization from foreign manufacturer/OEM should be attached in this regard along with e-offer.
2	Warranty will start from the AWB date. If there is delay in clearing the goods at Port of Consignee and arriving at RDSO the delay period will be included in the warranty.	Please read Para 11.0 (a) of Special conditions of tender contained in Bid Document Part-I Section-IV which specifies that the warranty of complete equipment shall be 24 months from date of installation and commissioning.
3	Is BG for EMD given by us on behalf of Principals acceptable?	Please read Para 0701 (d) of GT-EITT-March 2016 , which is quite clear.
4	Can the BG for EMD be converted to PBG in the event of order?	No. Please note that Indian Bidders shall submit/deposit EMD online through payment gateway of IREPS only against the subject e-tender. The manual/offline facility for submission of cost of tender document and EMD is not available to Indian Bidders vide notice to bidders given in Para 1.0 of Special conditions of tender contained in Bid Document Part-I Section-IV.
5	How to submit offer for civil works involved in erecting exhaust hoods etc wherever applicable and providing power line for each equipment.	Please read Item no. NS007, NS015, NS024 and NS033 of rate page of IREPS of this e-global tender wherein rate for installation commissioning and prove out test including civil work, foundation work, electrical work and exhaust work of the equipment required for test apparatus against each item should be quoted.

(B) The representative of prospective bidder has been advised to go through Paras relating to eligibility criteria, warranty and Annual Maintenance Contract (AMC) comprehensive type including spares parts and other paras given in Special Conditions of Tender contained in Bid Document Part-I Section-IV, Paras given in GT-EITT-March 2016 contained in Bid Document Part-I Section-I and GT-EGCC-March 2016 contained in Bid Document Part-I Section-II & Section-III attached with the e-tender.

(C) Further on perusal of para 15.0 relating to Payment terms given in **Special Conditions of Tender** contained in Bid Document Part I Section-IV, it has been found that Shipping document specified in 15.0 I.(a) (i) relating to Payment terms, is mentioned as **one copy of the negotiable air way bill with 3 non-negotiable copies**. Since mode of shipment is through Ocean, therefore "**one copy of negotiable cum original bill of Lading and with 3 non negotiable copies**" should be read in para 15.0 I.(a) (i) in place of existing entry.
