

Specification for supply and installation of modular furniture in Computer Directorate at RDSO, Manak Nagar, Lucknow.

1 Work Stations:-

- width) and 1200mm high having tile based partition each provided with storage pedestal 1.1 Modular Furniture Work Stations having work surface size 1500mm X 1500mm (600mm drawer and an adjustable wheel mounted CPU trolley.
- top height 750 mm. The work surfaces are fitted with the standard wire manager caps. The Table top to be half of 25 mm thick pre-laminated particle board with PVC banding. Table edges of the work surfaces will be sealed with PVC edge banding.
 - 1.3 The top of the workstation shall be factory made laminated of approved shade. The bottom shall have a backing laminate.
 - 1.4 The cable manager on the work surface shall be of flexible plastic component for easy and
- 1.5 Keyboard pull out tray made of durable ABS (Acrylonitrile Butadiene Styrene) material shall be on sliding telescopic channels.
- under the work surface. Drawer shall have channel arrangement for smooth operation, with 1.6 Pre laminated 3 drawer pedestals with 2 equal size drawers and 1 file drawer dully fixed stainless steel handle and suitable locking arrangement.
 - Adjustable wheel mounted CPU trolley made up of 1 mm thick CRCA 'D' grade MS duly powder coated. 1.7
- Raceways: 2 level raceways are provided on inside frame of each workstation for data and the power cables to run at different levels. 1.8

2. Frame:-

- CRCA (Cold Rolled Cold Annealed) MS grade D formed into channels duly powder coadted. These vertical channels shall have suitable and sturdy arrangement to accept tile cladding. The steel frame of minimum thickness 50 mm shall be made from minimum 1.0 mm thick
- 2.2 The connectors to the frames are made out of ABS plastic of a matching colour to the trims.
 - Panel should have cut-outs of required sizes for installing electrical switch boards 2.3
- All frames are fixed with aluminium trims. These trims are finished in an epoxy powder 2.4
- End cap, Inline Cap, Universal Caps shall be of ABS plastic.2 way/3 way post shall made up of ABS plastic. 2.5

3. Tile Constructions

- Tiles shall be offered for options, i.e. Fabric tile (tack able/Acoustic/Pin up Tile) or/and Laminate Tile/white board marker tiles.
- Fabric Tiles base shall be made of minimum 6 mm thick MDF (Medium Density Fibre) and covered with Fabric of choice. 3.2
- 3.3 Laminate Tiles constructed out of 6 mm thick pre-lamented Particle board edge banded by PVC edge banding.
- Whiteboard marker tiles are made out of 6 mm MDF with glossy highly wear resistant face laminates with a balancing laminate on the back. 3.4

4. Work Station Chairs:-

- 4.1 Chair back to be flexible, double layered multi curvature with cushion.
 - The chair should have a stroke gas-lift for seat height adjustment.

- 4.3 The seat and back should be foam-cushioned and back should have ABS cover.
- 4.4 The chair base should be of nylon material with glass filled nylon castors with embedded metal rings and ribs with nylon wheels.
- 4.5 There should be plastic moulded arms and push-back mechanism (2 point locking facility).
