Max Speed to be permitted for high capacity AC EOG Double Decker Chair Car (width 3050mm) fitted with pneumatic suspension at the secondary stage on FIAT bogies (LWSCZDAC1)

The issue raised by SECR letter forwarded vide Carriage Directorate's above reffered note been examined and comments are as under:

1. It is observed that the final speed certificate for operation of BG High Capacity AC EOG Double Decker Chair Car coaches (width 3050mm) and two LHB power cars fitted with pneumatic suspension at the secondary stage on Fiat bogies up to a maximum speed of 160kmph on track maintained to C&M-I Vol-I standard track has been issued after obtaining dispensation from oscillation trials on the basis of satisfactory oscillation trials conducted with BG High Capacity AC EOG Double Decker Chair Car coaches (width 3135mm) as contained in Report No. MT-1095/F which has been accorded by CCRS. It seen from the RDSO report no. MT-1095/F that trial on 20 curve has been done on a requisite speed of 130kmph with full cant value of 165mm and cant deficiency of 100mm in case of C&M.I Vol.I standard track. In view of above, para 2.1.3 of Final Speed Certificate for operation of BG High Capacity AC EOG Double Decker Chair Car coaches (width 3050mm) and two LHB power cars fitted with pneumatic suspension at the secondary stage on Fiat bogies on C&M-1, Vol-I track issued vide letter no. MC/CB/AC/DD dated 15-11-2011 is amended as below:

The maximum permissible speed on curves shall be decided on the basis of existing provision of the Indian Railway Permanent Way Manual, second reprint 2004.

2. However, it is obderved from RDSO report no. MT-1053/F that trial on 2° curve has not been done on requisite speed of 115kmph with full cant value of 140mm and cant deficiency of 75mm in case of Other than C&M.I Vol.I standard track. Therefore para 2.1.3 of final speed certificate for operation of BG High Capacity AC EOG Double Decker Chair Car coaches (width 3050mm) and two LHB power cars fitted with pneumatic suspension at the secondary stage on Fiat bogies on other than C&M-1, Vol-I track issued vide letter no. MC/CB/AC/DD dated 15-11-2011 and para 2.1.2 of amendment no.1 dated 11.07.2013 holds good as nothing is mentioned about value of cant deficiency taken in the reort MT-1053/F.
