After demolishing the wall, malwa is to be completely removed from the site and dumped at site directed by Town Engineer (TEN) of RDSO. B) SPECIAL CONDITIONS FOR THE WORK:

1. Work Experience: Firm should have carried out (completed) work of civil works like tiling or provision of compound wall or drainage etc., for government organization since 1st January' 2014. Details to be submitted in the following format:

2. **Warranty Period:** 3 years from the date of completion of installation work. Any damage/under performance of the system apparently because of inferior quality of material shall be repaired/ replaced by the firm to the satisfaction of RDSO SA.
3. **Work completion time:** 90 days
4. **Payment Terms:**
 - a. 95% payment, after satisfactory completion of work.
 - b. 5% amount of the total cost of work shall be withheld towards security deposit. The security deposit shall be released after completion of 3 years warranty period, subject to satisfactory performance of the work executed.
5. The quantity indicated above may vary by 20%. The payment terms and conditions shall remain same for the revised final quantity.
6. Tenderer shall be responsible for payment of all taxes.
7. All material used in construction of court should be of good quality and of reputed brands.
8. In case of any discrepancy or non-compliance w.r.t. above mentioned points is observed, the offer shall be liable to be rejected.
9. RDSOSA reserves the right to accept or reject the offer without assigning any reason. Tenderer shall have no claim in case his offer is rejected.
10. Following facilities shall be provided to the Contractor, free of charge, only towards utilization in execution of work:
 - a. Water and electricity
 - b. Space for storage of construction material
11. Contractor will be responsible for taking all necessary measures for ensuring safety at work place and of its workers. Contractor shall associate with the other contractors of Synthetic court and electrical work in a co-ordinated manner.

C) SUBMISSION OF OFFER:

The offer shall be submitted in sealed envelope covering the details given below:

1. Rate Sheet, as per format given in Schedule of Work, mentioned in point (A) above. Deviations, if any, vis-a-vis schedule of work should be clearly mentioned. If in addition to this Schedule of work, any other related work considered essential is required to be one, then it should be covered within the overall quoted cost.
2. Details of Work Experience along with documentary evidence, as mentioned in point (B) 1 above.
3. Acceptance of conditions mentioned in points (B) 2 to 11 above.
4. Verification of satisfactory compliance for execution of the work shall be done by authorised representative of RDSOSA.

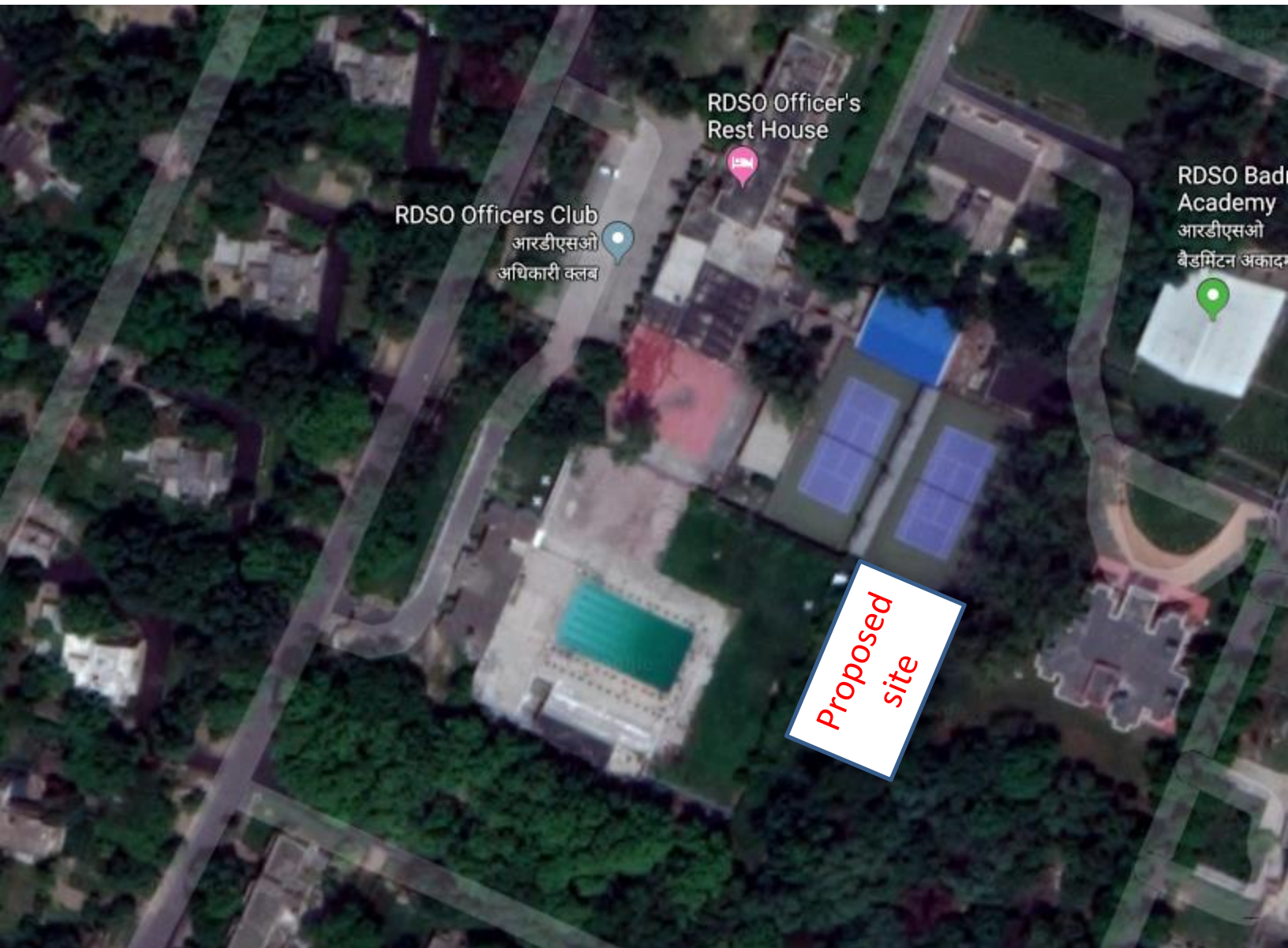


Figure 1 Proposed Site location
