A meeting was held at RDSO on 27.9.2018 to discuss the failures of Spheribloc for 3-phase Electric Locomotives. During the meeting following points were discussed:

- (i) Since spheribloc is a rubber material, it has shelf life hence Zonal railways were advised to procure spheriblocs in staggered manner to meet their requirements.
- (ii) ELS/LGD has reported high rate of failure of BHC make in the period from April 2018 to August 2018. The firm was advised to visit ELS/LGD and submit investigation report to RDSO.
- (iii) Zonal Railways have pointed out large number of failure of Dampers (Mainly Vertical damper). It was pointed out that poor quality of spheribloc in dampers is leading to failure of dampers. Railways were advised to send make wise, location wise and cause wise failure data of dampers so that quality of spheribloc of dampers can be analyzed.
- (iv) Zonal Railways have pointed that firms supply dampers in loco sets only whereas life of vertical damper is much lesser than other dampers. This leads to shortage of vertical dampers as compared to other type of dampers. Representative of ELS/AQ reported that damper manufacturers are not giving even budgetary quotation of individual dampers. CLW is requested to advise the firms to give their offers as required by shed for vertical damper supply.
