- 1. No representative from ELS/GZB attended the meeting.
- 2. Since Observation regarding the performance of the oil after trial has not received from ELS/GZB till date, so it cannot be commented upon whether to use Servosyn Gear 460 RR oil or not.
- 3. M/s IOCL stated that. Servosyn Gear 460 RR' gear case oil is a synthetic based lubricant and existing M/s Castrol make Optimal Optigear 220' is mineral based oil. As per M/s IOCL performance of Servosyn Gear 460 RR' of gear case oil is found better compare to M/s Castrol make optimal Optigear 220' during the field trial also degradation is found less in Servosyn Gear 460 RR' of gear case oil compared to M/s Castrol make optimal Optigear 220'.

Firm representative stated that in similar type fully suspended gear case of also servosyngear 460 RR' oil is being used motive power directorate of RDSO has approved for changing of oil Optimal Optigear 220 oil to servosyngear 460 RR' oil.
