Rates are inclusive of all taxes i.e. GST, cost of labours, materials, tools, equipment, plant and machinery, transportation arrangement, fuel etc.

- 1. Approximate Quantity : 1250 Sqm**
- 2 Estimated Cost : Rs.23750/- inclusive of GST**
- 3. Completion Period : One month from the date of acceptance.**
- 4. Warrantee Period : Five Years after successful completion of work.**
- 5. Security Deposit : Security deposit @ 10 % of quoted value of work.
In the form of:-**
 - i) FDR in favour of WAO/Rail Spring Kharkhana, Sithouli should be deposited before issue of acceptance letter.
 - or**
 - ii) May be deducted from the bill.
- 6. Scope of work : Work includes:-**
 - i) Treatment to soil at wall and floor junction.
 - ii) Treatment to wall along wooden work.
 - iii) Treatment to wooden fixtures like false ceiling, cup boards, wooden doors, wooden windows Wooden partitions etc.
- 7. Eligibility : Only Firms registered on IREPS are eligible.**
- 8. Terms & Conditions:**
 - a. The rate quoted should include all taxes i.e. GST, cost of labour, materials, tools, equipment, plant and machinery, transportation arrangement, fuel etc. No. extra payment quoted rates will be made.
 - b. Payment will be made on the basis of actual measurement on plinth area basis.
 - c. Payment will be made after successful completion of work and Security Deposit will be released after warrantee period of five years.
 - d. No advance payment will be made to the contractor.
 - e. **Contractor :**
 - i) Contractor should execute the work of "Anti Termite Treatment of Hostel Buildings at CAMTECH, Gwalior" to the satisfaction of Engineer In Charge.
 - ii) Anti Termite Treatment of Hostel Buildings at CAMTECH, Gwalior may be done either manually or by machine as per site requirement.

- iii) Should dispose the sludge away from CAMTECH premises to the nominated place for disposal of work by Municipal Corporation at his own cost & means.
- iv) Shall provide all necessary safety equipments to their workers for safety.
- v) Shall not be liable in any manner whatsoever to indemnify CAMTECH for any loss or injury or damages or liquidated damages of any kind what so ever, however caused.
- vi) Shall be entitled to depute his employee or authorized representative to enter the CAMTECH premises, at all reasonable times to do the work.
- vii) Payment will be made after successful completion of work.
- viii) Contractor should submit bill in triplicate for payment after successful completion of work.
- ix) Contractor should submit copy of IREPS registration ID, PAN card, GSTIN and complete details of Bank like account number, Branch name and IFSC for payment.
- x) Payment will be made available through NEFT/RTGS through WAO/RSK//Sithouli.

9. **Warranty:** Anti Termite treatment in Hostel buildings at CAMTECH, Gwalior shall remain termite proof for a period of Five years from the date of completion of work. If any defects or termite apparent during this period, it should be retreat immediately without any cost (free of Cost) by the contractor.

10. **Penalty Clause:** If any damage to Railway property is caused by the contractor, it should be rectified immediately with his own cost otherwise cost of repairing will be recovered from bill.

11. **Jurisdiction:** Any dispute or difference arising between the parties shall be within the preview of Executive Director/CAMTECH/Gwalior and his decision will be final.

12. Timely completion of work by contractor & timely payment of all charges by the railway to the contractor shall be the essence of this agreement.

13. This is the entire agreement between the parties and no alternation or amendment is valid unless signed by a person duly authorized by the contractor & Railway.
