- 1. Railway Board vide letter no. 2014/safety (DM)/7/1 dated 25.08.2014 had advised for provision of VCD counter in all locomotives.
- 2. In conventional locomotive equipped with **M**icro**P**rocessor based **C**ontrol and fault diagnostic **S**ystem MPCS version 3 separate VCD device is not provided and VCD functionality is implemented in MPCS version 3 itself.

3. To implement the feature of counter in VCD functionality of MPCS version 3, this amendment of TC-119 revision '1' amends the clause no. 6.2 'Main screen or default screen' given on page number 66/85 And 'Default screen in single Loco' and 'Default screen for multi consist locomotives' given on page no. 67/85 on technical circular number RDSO/2012/EL/TC/119 Rev-1 dated 20.3.2013 as given below:

- 4. This VCD penalty brake counter cannot be resetted manually or by software. Once the counter value reach to its maximum value i.e. 99999, on the next VCD Penalty Brake (PB) application counter will become 00000 and on the next VCD Penalty Brake (PB) application counter will become 00001 and this cycle will be continue.
- 5. Technical circular no. RDSO/2012/EL/TC/119 Rev-1 dated 20.03.2013 along with amendment-1, 2 & 3 specifies the technical details of MPCS version-3 with specification no. ELRS/SPEC/MPC-FDS/0001 Rev.-3 of Apr 2013.
